TERMS AND CONDITIONS APPLICABLE TO ALL VISITORS TO NORMAN PARK COMMUNITY SPORTS CENTRE

1. By visiting the grounds of the Community Sports Centre, at Norman Park (the “Sports Centre”), you agree to be subject to these terms and conditions, which may be amended by us from time to time by posting the amended version on our website at www.npcsc.co.uk

Visitor Admission and Conduct

2. You agree, always while visiting the Sports Centre, to comply with these terms and conditions and with any directions given to you by us, our employees or authorised representatives.
3. You are welcome to book and attend exercise classes subject to availability. Bookings can be made online at www.npcsc.co.uk or at the reception desk at the Sports Centre.
4. All visitors to the Sports Centre are welcome to visit the Track Side Café, unless there is a private booking, the opening hours are on the website at www.npcsc.co.uk
5. To use the Track Facilities please purchase a session admission ticket or provide confirmation of your monthly Direct Debit payment at the entrance to the Sports Centre unless you are visiting (with our permission) as a guest athlete during a competitive event.
6. The purchase of a session Track Facility admission ticket allows you access to and permits you to use the athletics track or field facilities only for the relevant session and on the date of purchase.
7. You must always comply with the rules of ‘Track & Field Conduct’ on Training Sessions.
8. We reserve the right in our sole discretion to refuse the admission of any person to the Sports Centre, to refuse permission to any person to use any part of the Sports Centre, or to eject any person from the Sports Centre, and our decision shall be final and binding. Without prejudice to the generality of the foregoing, we have the right to refuse admission or permission to, or eject from the Sports Centre, any person who is:

- (1) under the influence of drugs or alcohol, and/or
- (2) conducting themselves in an inappropriate manner, and/or
- (3) inappropriately or inadequately attired

9. We reserve the right to close the Sports Centre during ordinary opening hours and to require visitors to leave if circumstances reasonably so require.
10. Smoking (including the use of e-cigarettes) and/or the use or consumption of drugs at the Sports Centre is strictly prohibited.
11. You are not permitted to use any of the track facilities or gym under the influence of alcohol.
12. Nuisance, offensive or abusive behaviour of any kind is prohibited, including any form of abusive, racist, or sexist language and any type of anti-social conduct.
13. Animals, other than guide, hearing, or assistance animals, will not be admitted to the Sports Centre.
14. Any person in possession of an item which is illegal, or which is reasonably considered by us, our employees, or authorised representatives to be dangerous, may be refused admission or ejected from the Sports Centre.
15. In relation to photography at the Sports Centre, you agree as follows.

- (1) You agree not to bring any camera, video camera, sound recording equipment or other photographic equipment onto the Sports Centre for commercial purposes without first obtaining written permission from us.
- (2) You agree not to photograph and/or record video footage of any other visitor to the Sports Centre without first obtaining their permission to do so.
- (3) You agree that we, our employees, or our authorised representatives may (on demand made on reasonable grounds) have access to any photographs or video footage that you have taken at the Sports Centre. You also agree to comply immediately with any request by us, our employees or authorised representatives that photographs or video footage be deleted if they are reasonably considered (by us, our employees or representatives) to be offensive to or to infringe the privacy or other rights of any visitor or of any of our employees or authorised representatives.
- (4) Occasionally, we or other persons authorised by us carry out photography and/or video recording at the Sports Centre, which may capture images of visitors. By entering the Sports Centre, you agree that we or such other persons authorised by us may capture and use in perpetuity such images in promotional, advertising or publicity material in any format whatsoever, without granting you any right to payment. When filming takes place, we will display a sign giving notice thereof.

Liability

16. You acknowledge and agree that you will be liable to us for any damage caused by you to the Sports Centre or to any of their fixtures, fittings or contents and/or for any injury caused by you to any of our employees or authorised representatives or to any other visitors during your visit. Except in respect of any personal injury or death caused directly by our negligence, or any other liability that cannot (as a matter of law) be excluded or limited:
- (1) we exclude liability (whether in contract, tort, negligence, breach of statutory duty or otherwise) for any loss, damage, cost, expense, injury or death suffered by you or for any loss or damage to any item of property belonging to you, howsoever arising;
 - (2) any other liability that we have to you shall be limited to the price of your admission ticket;
 - (3) under no circumstances will we be liable to you or to any third party for any wasted expense, loss of income or profit, or any indirect, consequential, financial, or economic loss or damage, howsoever arising.

General

17. These terms and conditions shall be governed by and construed in accordance with English Law.
18. Any disputes arising under or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts of England and Wales.
19. The Sports Centre is open to all.
